MANAGEMENT DISCUSSION AND ANALYSIS

The following Management Discussion & Analysis (“MD&A”) prepared as of May 11, 2011, should be read in conjunction with DHX Media Ltd.’s (the “Company” or “DHX”) unaudited interim consolidated financial statements and accompanying notes for the three and nine months ended March 31, 2011 and 2010, as well as the Company’s annual MD&A and audited consolidated financial statements for the years ended June 30, 2010 and 2009. The unaudited interim consolidated financial statements and accompanying notes for the three and nine months ended March 31, 2011 and 2010 have been prepared in accordance with Canadian generally accepted accounting principles.

The Company’s auditors, Pricewaterhouse Coopers LLP, have not reviewed the unaudited interim consolidated financial statements and accompanying notes for the three and nine months ended March 31, 2011 and 2010.

DHX is a public company incorporated under the Canadian Business Corporations Act whose common shares are traded on the Toronto Stock Exchange (“TSX”) admitted on May 19, 2006 (symbol DHX). Additional information relating to the Company can be found on its website at www.dhxmedia.com or on SEDAR at www.sedar.com. The Company delisted its shares from the AIM market of the London Stock Exchange effective October 1, 2009.

The Company prepares its financial statements in accordance with Canadian generally accepted accounting principles. Figures in this MD&A are shown as millions (for example, \$100,000 is shown as \$0.10 million) and are approximate and have been rounded to the nearest ten thousand.

Business of the Company

DHX is a leading independent supplier and distributor of television and film productions. The Company was originally the result of the combination of The Halifax Film Company Limited (“**Halifax Film**”) and Decode Entertainment Inc. (“**Decode**”) during Fiscal 2006 and at the time of initial public offering. Since that time DHX has added Studio B Productions (“**Studio B**”) on December 4, 2007, imX Communications Inc. (“**imX**”) on July 20, 2008, and Wildbrain Entertainment Inc. (“**DHX Wildbrain**”) on September 14, 2010 (See “Wildbrain Acquisition” and “Acquisitions” sections of this MD&A and the annual MD&A for the years ended June 30, 2010 and 2009 posted on SEDAR at www.sedar.com). As previously announced in the Company’s September 2010 press release relating to rebranding, all the Company’s subsidiaries have been rebranded under the name DHX Media. Consistent with this initiative, throughout this MD&A and going forward the locations have been relabelled as follows: Halifax Film and imX are now referred as “**DHX Halifax**”, Decode as “**DHX Toronto**”, Studio B as “**DHX Vancouver**”, and Wildbrain as “**DHX Wildbrain**”.

The Company produces, distributes, and exploits the rights for television and film programming. DHX’s primary focus is on children’s, youth, and family (collectively “**Children’s and Family**”) productions because of the international sales potential and longer-term and multiple revenue streams that this genre of programming provides. Children’s and Family programming travels across cultures more easily than other genres and can therefore be sold into numerous markets, typically has a longer lifespan than other genres, and can be leveraged for merchandising and licensing revenues.

DHX’s content library includes over 2,450 half-hours of programming and over 60 individual titles produced. The Company has over 15 children’s series currently in first window broadcast on multiple major cable and broadcast networks in North America and internationally, including, *Yo Gabba Gabba*, *Waybuloo*, *Super Why*, *The Mighty Jungle*, *Bo on the Go!*, *Franny’s Feet*, *Dirtgirlworld*, *How to be Indie*, *Animal Mechanicals*, *Kid vs. Kat*, and *Martha Speaks*. The Company’s prime-time production slate also includes notable achievements in the comedy genre, including the award-winning Canadian prime-time comedy series *This Hour Has 22 Minutes*, which is produced for the CBC and recently completed its Season 18. *Canada’s Super Speller* was recently awarded two 2010 Gemini Awards for Best Children’s or Youth Non-fiction Program or Series, and Best Host in a Pre-school Children’s or Youth Program or Series. The Company operates from its offices and production facilities in Halifax, Toronto, and Vancouver, Canada, and Los Angeles, United States of America (“**USA**”), producing content for distribution in domestic and international markets which is marketed via its Toronto based sales group and licensed via its Los Angeles based licensing group.

Revenue Model

The Company historically earns revenues primarily from four categories: 1) proprietary production, which includes Canadian and other rights proprietary programs, 2) distribution of its proprietary and third party acquired titles, 3) producer and service fees, which includes production services for third parties and equity investments, and 4) other revenues which includes rental of studios and office facilities, music and royalty revenue, new media revenue, and licensing revenue on titles in the DHX library including new for Q1 2011 and onward *Yo Gabba Gabba Live! There’s a party in my City* (“**Yo Gabba Gabba Live!**”) stage tour revenues. The Company is able to generate revenue from productions by licensing its initial broadcast rights and pre-licensing of territories for its programs. Production revenues include the initial broadcast license revenues and any pre-sales or distribution advances included in the initial financing of the production of a film and television program. Once a production is completed and delivered, the program is included in the Company’s library of film and television programming. Further revenue from exploitation of the program is included in distribution revenue. The Company also generates revenue from programs in which it retains Canadian and other limited participation rights and, in certain instances, from production services for productions whose copyright is owned by third parties and equity investments.

Production Revenue

The Company derives proprietary production revenues, which includes other proprietary titles with Canadian and other rights, from the grant of initial broadcast rights for the initial showing of commissioned productions and pre-licensing of territories. These fees are typically collected partially upon commissioning of a production, during production, and finally once a completed production is delivered for broadcast, and at some point in time after delivery as a holdback (See “Critical Accounting Policies and Estimates” section of this MD&A for details on revenue recognition).

Distribution Revenue

The Company is able to retain the ownership rights to its proprietary, other proprietary titles, and third party acquired titles, which permits the Company to generate further revenues from the distribution of the Company’s productions. In addition to generating revenues from the sale of initial broadcast rights, the Company is able to concurrently generate revenues from the sale of broadcast rights in other jurisdictions and on other platforms (such as DVD and video) for specified periods of time. Distribution revenue also includes theatrical and other revenues generated on its feature films.

Producer and Service Fee Revenue

As reclassified in Q2 2010, this category includes revenue accounted for using the percentage of completion method for revenues for service and corporate overhead fees earned for producing productions.

Other Revenue

Other revenue includes rental of studios, equipment, and office facilities, music and royalty including merchandising and licensing (“M&L”), new media revenue, and new for Q1 2011 and onward revenue from the licensing of *Yo Gabba Gabba* and *Yo Gabba Gabba Live!*.

¹The financial information for the three months ended March 31, 2011 in the table includes a full quarter’s results for DHX Halifax, DHX Toronto, and DHX Vancouver, and DHX Wildbrain. The financial information for the nine months ended March 31, 2011 in the table includes a full nine months’ results for DHX Halifax, DHX Toronto, and DHX Vancouver, but only 198 days activity for DHX Wildbrain (see–“Wildbrain Acquisition” section of this MD&A). The financial information for the three and nine months ended March 31, 2010 in the tables include full results for DHX Halifax, DHX Toronto, DHX Vancouver, but no activity for DHX Wildbrain.

Results for the nine months ended March 31, 2011 (“Nine Months 2011”) compared to the nine months ended March 31, 2010 (“Nine Months 2010”)

Revenues

Revenues for Nine Months 2011 were \$43.78 million, up 39% from \$31.39 million for Nine Months 2010. The increase in Nine Months 2011 was generally due to the addition of DHX Wildbrain.

Proprietary production revenues: Proprietary production revenues for Nine Months 2011 of \$12.59 million were down 22% compared to \$16.08 million for Nine Months 2010. The overall decrease was made up of a 5% increase to \$5.57 million (Nine Months 2010-\$5.29 million) in proprietary production revenue for DHX Halifax, a 70% decrease to \$2.95 million for Nine Months 2011 (Nine Months 2010-\$9.71 million) for DHX Toronto, and a 277% increase to \$4.07 million for DHX Vancouver (Nine Months 2010-\$1.08 million).

For Nine Months 2011, the Company accounted for 108 half-hours - \$12.59 million of proprietary film and television program production revenue versus the 214.5 half-hours for Nine Months 2010, where the programs have been delivered and the license periods have commenced for consolidated entities. Included in these totals for Nine Months 2011 are 30 half-hours - \$2.95 million (Nine Months 2010-87.0 half-hours - \$3.55 million) for other proprietary titles where the Company has Canadian rights and other rights, which are being accounted for using the percentage of completion method (note, in addition, for Nine Months 2011 the Company delivered 40 half-hours of *Waybuloo* Season II to Treehouse which have already been accounted for in prior quarter delivery totals). Nine Months 2011 proprietary deliveries were in line with scheduled deliveries and Management’s expectations.

Distribution revenues: For Nine Months 2011, distribution revenues were down 31% to \$6.19 million from \$8.98 million for Nine Months 2010, generally due to timing of license periods for existing contracts on hand and the lagging effect on distribution revenues of fewer Fiscal 2010 and 2011 deliveries. For Nine Months 2011, the Company recognized revenue on several contracts throughout its existing library and delivered episodes of newer titles. Some of the more significant sales were on the following titles: *Dirtgirlworld* Season I, *The Latest Buzz* Seasons I-III, *Animal Mechanicals* Seasons I - III, *Martha Speaks* Season I and II, *Grandpa in my Pocket* Seasons I and II, *Super Why!* Season I, *Kid vs. Kat* Seasons I and II, *How to be Indie* Season I, and *Waybuloo* Seasons I and II.

Intellectual property (“IP”) rights on third party produced titles: As part of the maturation of DHX, specifically the experience our in house international television distribution team has gained over the years along with the licensing expertise the Company has gained from the Wildbrain acquisition, the Company is strategically targeting third party produced titles for IP

rights. The Company is aggressively pursuing and adding half-hours to the library deploying this strategy. Due to our strong balance sheet and position in the industry, we are able to add significant exploitation and distribution rights through this avenue without taking great risks on capital. This strategy remains consistent with our previously stated goal of increasing, by 5-10% annually, the Company's library totals for new titles upon which the Company owns IP rights.

² Additionally the Company has committed deals for additional third party produced titles to be added to the library totalling 81 half-hours on the following titles: Rastamouse, She Zow, How to be Indie and Ha Ha Hairies. These deliveries are expected to occur in 2011 and 2012.

Producer and service fee revenues: For Nine Months 2011, Management was very pleased with the growth in this category as the Company earned \$11.96 million for producer and service fee revenues, an increase of 218% over the \$3.76 million for Nine Months 2010. DHX Vancouver earned \$5.66 million and DHX Wildbrain earned \$6.30 million for Nine Months 2011 (Nine Months 2010 was entirely DHX Vancouver). For Nine Months 2011, the breakdown for major projects over \$0.10 million for DHX Vancouver was \$3.52 million for *My Little Pony* Season 1, \$1.47 million for *My Little Pony* Season 2, \$0.23 million for *Killer Mountain*, a movie of the week, \$0.14 million for *George of the Jungle* Season I, and \$0.27 million for *Ice Road Terror*, a movie of the week. For Nine Months 2011, the breakdown for major projects over \$0.10 million for DHX Wildbrain was \$1.85 million for *Monster High* Seasons 1-5, \$0.23 million for *Oki's Oasis* Season 1, \$2.97 million for *The Ricky Gervais Show* Seasons 1 and 2, \$0.15 million for *Japan Day* commercial, \$0.10 million for *Sideway (Game) Project*, \$0.26 million for *Hard Times of R.J. Berger* Season 2, and \$0.35 million for *Go Time* Pilot.

Music and royalty revenues (new for Nine Months 2011, including M&L on *Yo Gabba Gabba*): For Nine Months 2011, music and royalty revenues, including M&L, increased 659% to \$10.85 million (Nine Months 2010-\$1.43 million). Overall, music and royalty revenues, including M&L, were up 659% mainly due to the addition of DHX Wildbrain which has significant licensing revenue, specifically for *Yo Gabba Gabba*. Traditional DHX music and royalty revenues, including M&L, was \$1.30 million for Nine Months 2011 (Nine Months 2010-\$1.43 million). Gross *Yo Gabba Gabba Live!* revenues were \$7.72 million and \$1.83 million for other M&L on *Yo Gabba Gabba*.

New Media Revenues: For Nine Months 2011, new media revenues increased 205% to \$1.86 million (Nine Months 2010-\$0.61 million) including \$1.56 million for the start of UMIGO (you make it go). The Company will team with WTTW, Chicago's premier public television station, to develop UMIGO, a transmedia property, in collaboration with the Michael Cohen Group, LLC. UMIGO will launch as a web-based property and is intended to later transition into a television series and line of consumer products. UMIGO will test the boundaries of even the most creative imaginations while providing a solid foundation in mathematics. The multi-platform strategy will make UMIGO accessible to children and families of all social-economic levels.

Rental revenues: For Nine Months 2011, rental revenues were \$0.33 million, down 38% from Nine Months 2010 of \$0.53 million, as a result of lower rental revenues of studio and office facilities to third parties of the Company's DHX Halifax Children's Studio, rental of currently unused office space in the Company's headquarters in Halifax, Nova Scotia, and rental of office and equipment of the Company's Toronto, Ontario office.

Gross Margin

Gross margin for Nine Months 2011 was \$17.54 million, an increase in absolute dollars of 44% compared to \$12.21 million for Nine Months 2010. The overall margin at 40% of revenue for Nine Months 2011 was at the high end of Management's expectations.

For Nine Months 2011, the margins for each revenue category in absolute dollars and as a margin percentage are as follows: production revenue margin of \$4.92 million or 39%, net producer and service fee revenue margin of \$3.32 million or 28%, distribution revenue margin of \$4.43 million or 72% (\$3.98 million or 64% when \$0.45 million for the amortization of acquired libraries is removed), new media margin at \$0.26 million, and rental revenue margin of \$0.34 million. For Nine Months 2011, music and royalty revenue, including M&L, less direct costs were \$4.27 million. The breakdown for music and royalty margin (including M&L) was \$1.29 million for traditional DHX music and royalty, \$2.41 million margin for *Yo Gabba Gabba Live!* tour, and \$0.57 million margin for M&L on other *Yo Gabba Gabba* licenses.

In particular, production, producer and service fee revenue, distribution, and M&L on *Yo Gabba Gabba* in terms of absolute dollars contributed \$4.92 million, \$3.32 million, \$4.43 million and \$2.98 million, respectively or 90% of the total margin. Production margin at 39%, based on product delivery mix, was at the high end of Management's range but in line with expectations. Producer and service fee margins can vary greatly and at 28% is in line with Management's expectations. Distribution margin can fluctuate greatly from title-to-title and at 72% is above Management's expectations.

Operating Expenses

Operating expenses for Nine Months 2011 were \$13.33 million compared to \$10.76 million for Nine Months 2010, an increase of 24%.

SG&A

SG&A costs for Nine Months 2011 were up 21% at \$11.78 million compared to \$9.71 million for Nine Months 2010. Specifically, SG&A costs (excluding DHX Wildbrain) for DHX Toronto, DHX Vancouver, and DHX Halifax were \$9.07 million (Nine Months 2010 \$9.71 million) and SG&A costs for the 198 days from date of acquisition to March 31, 2010 were \$2.71 million (Nine Months 2010 nil). Management was pleased with Nine Months 2011 SG&A costs (excluding DHX Wildbrain) at \$9.07 million, which was down 7% (ahead of expected reductions of 5%) as compared to Nine Months 2010.

Development Expenses and Other

During Nine Months 2011 development expenses were \$0.32 million (Nine Months 2010 \$0.03 million). During Nine Months 2011, other expenses were \$0.33 million (Nine Months 2010 nil) as a result of a one time charge for legal fees and litigation costs relating to a normal course legal matter settled during the period.

Impairment in Value of Certain Investment in Film and Television Programs

During Nine Months 2011, the Company recorded an impairment in value of certain investments in film and television programs of \$0.45 million (Nine Months 2010-\$0.23 million).

Loss from Strategic Investments

For Nine Months 2011, loss from strategic investments activities of \$0.03 million related to an unrealized capital loss from short-term investments held for trading (Nine Months 2010-nil) and nil for realized capital loss (\$0.02 million loss for Nine Months 2010).

EBITDA

For Nine Months 2011, EBITDA was \$6.08 million, up \$2.95 million or 94% over the \$3.13 million for Nine Months 2010. For Nine Months 2011, this was generally due to the increase in gross margin dollars of \$5.32 million, offset by an increase in SG&A of \$2.09 million and a \$0.28 million decrease in non-cash stock based compensation.

Amortization

For Nine Months 2011, amortization was down slightly to \$1.99 million (Nine Months 2010-\$2.07 million). For Nine Months 2011, the amortization of acquired libraries was \$0.45 million (Nine Months 2010-\$0.61 million) which relates to the library titles that have a maximum 20 year life for amortization purposes, have minimal ongoing cash costs associated with selling, and are viewed as long-term assets. For Nine Months 2011, amortization of PP&E was \$0.82 million (Nine Months 2010-\$0.65 million). For Nine Months 2011, amortization of intangible assets was \$0.72 million (Nine Months 2010-\$0.81 million) which relates to the intangible assets acquired as part of the acquisitions of Decode and Studio B.

Foreign Exchange Gain (Loss)

For Nine Months 2011, due to fluctuations of the Canadian dollar against the USD, GBP, and Euro since June 30, 2010, foreign exchange gain was \$0.16 million (versus a (\$0.53 million) foreign exchange loss for Nine Months 2010). The breakdown for Nine Months 2011 was as follows: (\$0.18 million) for realized foreign exchange loss (Nine Months 2010-(\$0.32 million) foreign exchange loss) on revenue and expense items translated at average rates for the period and was offset by a \$0.34 million in non-cash unrealized foreign exchange gain (Nine Months 2010-(\$0.21 million) unrealized foreign exchange loss) for balance sheet translations at the exchange rates in effect at each balance sheet date.

Interest

Interest for Nine Months 2011 decreased to \$0.08 million income versus \$0.19 million expense for Nine Months 2010. Interest consists of \$0.07 million for interest expense on long-term debt and \$0.12 million for interest and bank charges (Nine Months 2010-\$0.09 million and \$0.11 million, respectively), offset by interest income of \$0.11 million (Nine Months 2010-\$0.01 million).

Equity Loss and Non-Controlling Interest

For Nine Months 2011, the Company recorded an equity loss of \$0.27 million for its investment in Tribal Nova (Nine Months 2010-nil). For Nine Months 2011 the Company recorded nil for non-controlling interest (Nine Months 2010-\$0.01 million loss from non-controlling interest).

Income Taxes

Income tax for Nine Months 2011 was a \$0.81 million expense (Nine Months 2010-\$0.01 million recovery) made up of \$0.05 million expense (Nine Months 2010-\$0.05 million) for large corporation taxes, \$1.17 million expense (Nine Months 2010-\$0.07 million expense) for current income taxes, and future income tax recovery of \$0.41 million (Nine Months 2010-\$0.13 million recovery).

Net Income (Loss) and Comprehensive Income (Loss)

Net income and comprehensive income for Nine Months 2011 was \$1.63 million, compared to \$0.74 million loss for Nine Months 2010, or an improvement of \$2.37 million in absolute dollars. For Nine Months 2011, the overall improvement of \$2.37 million was due to changes over Nine Months 2010 of the following amounts: a gross margin increase of \$5.32 million, added to a \$0.45 million decrease in net interest and other expenses, which includes amortization, impairment in value of certain investment in film and television, and equity loss, offset by an increase in operating expenses of \$2.58 million and a \$0.82 million increase in provision for income taxes.

Results for the three months ended March 31, 2011 (“Q3 2011”) compared to the three months ended March 31, 2010 (“Q3 2010”)

Revenues

Revenues for Q3 2011 were \$12.28 million, up 36% from \$9.02 million for Q3 2010. The increase in Q3 2011 was due to increases in producer and service fee revenues and the addition of DHX Wildbrain.

Proprietary production revenues: Proprietary production revenues for Q3 2011 of \$2.49 million were down 54% compared to \$5.36 million for Q3 2010. The overall decrease was made up of a 23% decrease to \$1.44 million (Q3 2010-\$1.88 million) in proprietary production revenue for DHX Halifax, a 73% decrease to \$0.92 million for Q3 2011 (Q3 2010-\$3.44 million) for DHX Toronto, and a 225% increase to \$0.13 million for DHX Vancouver (Q3 2010-\$0.04 million).

For Q3 2011, the Company accounted for 32.5 half-hours - \$2.49 million of proprietary film and television program production revenue versus the 62.0 half-hours for Q3 2010, where the programs have been delivered and the license periods have commenced for consolidated entities. Included in these totals for Q3 2011 are 20 half-hours - \$0.92 million (Q3 2010-16.0 half-hours - \$0.90 million) for other proprietary titles where the Company has Canadian rights and other rights, which are being accounted for using the percentage of completion method. Q3 2011 proprietary deliveries were at the low end although in line with scheduled deliveries and Management’s expectations.

Distribution revenues: For Q3 2011, distribution revenues were down slightly to \$1.64 million from \$1.68 million for Q3 2010, generally due to timing of license periods for existing contracts on hand. For Q3 2011, the Company recognized revenue on several contracts throughout its existing library and delivered episodes of newer titles. Some of the more significant sales were on the following titles: *Dirtgirlworld* Season I, *The Latest Buzz* Seasons I-III, *Animal Mechanicals* Seasons I - III, *Martha Speaks* Season I and II, *Grandpa in my Pocket* Seasons I and II, *Super Why!* Season I, *Kid vs. Kat* Seasons I and II, *How to be Indie* Season I, and *Waybuloo* Seasons I and II.

IP rights on third party produced titles: (For further details on strategy and other information, please refer to the results for Nine Months 2011 compared to Nine Months 2010 “Intellectual property (IP) rights on third party produced titles” section).

Producer and service fee revenues: For Q3 2011, Management was very pleased with the growth in this category as the Company earned \$4.22 million for producer and service fee revenues, an increase of 225% over the \$1.30 million for Q3 2010. DHX Vancouver earned \$1.98 million and DHX Wildbrain earned \$2.24 million for Q3 2011 (Q3 2010 was entirely DHX Vancouver). For Q3 2011, the breakdown for major projects over \$0.10 million for DHX Vancouver was \$0.90 million for *My Little Pony* Season 1 and \$1.05 million for *My Little Pony* Season 2. For Q3 2011, the breakdown for major projects over \$0.10 million for DHX Wildbrain was \$1.30 million for *Monster High* Seasons 1-5, \$0.47 million for *The Ricky Gervais Show* Seasons 1-2, \$0.15 million for *Japan Day* commercial, \$0.22 million for *Hard Times of R.J. Berger* Season 2, and \$0.25 million for *Go Time* Pilot.

Music and royalty revenues (including M&L on Yo Gabba Gabba): For Q3 2011, music and royalty revenues, including M&L, increased 382% to \$2.41 million (Q3 2010-\$0.50 million). Overall, music and royalty revenues, including M&L, were up 382% mainly due to the addition of DHX Wildbrain, specifically for *Yo Gabba Gabba*. Traditional DHX music and royalty revenues, including M&L, was \$0.24 million for Q3 2011 (Q3 2010-\$0.50 million). Gross *Yo Gabba Gabba* revenues were \$0.14 million for *Yo Gabba Gabba Live!* and \$1.47 million for other M&L.

New Media Revenues: For Q3 2011, new media revenues increased to \$1.42 million (Q3 2010 - nil) including \$1.38 million for UMIGO (see Nine Months 2011 *New Media Revenues* section of this MD&A for further details).

Rental revenues: For Q3 2011, rental revenues were \$0.10 million, down 44% from Q3 2010 of \$0.18 million, as a result of lower rental revenues of studio and office facilities to third parties of the Company’s DHX Halifax Children’s Studio, rental of currently unused office space in the Company’s headquarters in Halifax, Nova Scotia, and rental of office and equipment of the Company’s Toronto, Ontario office.

Gross Margin

Gross margin for Q3 2011 was \$5.51 million, an increase in absolute dollars of 65% compared to \$3.34 million for Q3 2010. The overall margin at 45% of revenue for Q3 2011 was above Management’s expectations.

For Q3 2011, the margins for each revenue category in absolute dollars and as a margin percentage are as follows: production revenue margin of \$0.75 million or 30%, net producer and service fee revenue margin of \$2.00 million or 47%, distribution revenue margin of \$1.18 million or 72% (\$1.07 million or 65% when \$0.11 million for the amortization of acquired libraries is removed), new media margin at \$0.08 million, and rental revenue margin of \$0.10 million. For Q3 2011, music and royalty revenue, including M&L, less direct costs were \$1.40 million. The breakdown for music and royalty margin (including M&L) was \$0.80 million for traditional DHX music and royalty, \$0.04 million margin for *Yo Gabba Gabba Live!* tour, and \$0.56 million margin for M&L on other *Yo Gabba Gabba* licenses.

Operating Expenses

Operating expenses for Q3 2011 were \$4.46 million compared to \$3.36 million for Q3 2010, an increase of 33%.

SG&A

SG&A costs for Q3 2011 were up 37% at \$4.14 million compared to \$3.03 million for Q3 2010. Specifically, SG&A costs (excluding DHX Wildbrain) for DHX Toronto, DHX Vancouver, and DHX Halifax were \$2.99 million (Q3 2010 \$3.03 million) and SG&A costs for DHX Wildbrain for Q3 2011 were \$1.15 million (Q3 2010 nil). Q3 2011 SG&A costs (excluding DHX Wildbrain) at \$2.99 million were down 2% as compared to Q3 2010.

Development Expenses and Other

During Q3 2011 development expenses and other (all related to development expense) were \$0.21 million (Q3 2010 nil).

Impairment in Value of Certain Investment in Film and Television Programs

During Q3 2011, the Company did not record an impairment in value of certain investments in film and television programs (Q3 2010-nil).

Loss from Strategic Investments

For Q3 2011, loss from strategic investments activities of \$0.01 million related to an unrealized capital loss from short-term investments held for trading (Q3 2010-nil).

EBITDA

For Q3 2011, EBITDA was \$1.46 million, up \$0.98 million or 204% over \$0.48 million for Q3 2010. For Q3 2011, this increase was due to the increase in gross margin dollars of \$2.17 million, offset by an increase in SG&A of \$1.12 million and a \$0.07 million decrease in non-cash stock based compensation.

Amortization

For Q3 2011, amortization was up slightly to \$0.64 million (Q3 2010-\$0.62 million). For Q3 2011, the amortization of acquired libraries was \$0.11 million (Q3 2010-\$0.15 million) which relates to the library titles that have a maximum 20 year life for amortization purposes, have minimal ongoing cash costs associated with selling, and are viewed as long-term assets. For Q3 2011, amortization of PP&E was \$0.33 million (Q3 2010-\$0.20 million). For Q3 2011, amortization of intangible assets was \$0.20 million (Q3 2010-\$0.27 million) which relates to the intangible assets acquired as part of the acquisitions of Decode and Studio B.

Foreign Exchange Gain (Loss)

For Q3 2011, due to fluctuations of the Canadian dollar against the USD, GBP, and Euro since December 31, 2010, foreign exchange gain was \$0.18 million (Q3 2010-(\$0.10 million) foreign exchange loss). The breakdown for Q3 2011 was as follows: \$0.04 million for realized foreign exchange gain (Q3 2010-(\$0.02 million) foreign exchange loss) on revenue and expense items translated at average rates for the period and \$0.14 million in non-cash unrealized foreign exchange gain (Q3 2010-(\$0.08 million) unrealized foreign exchange loss) for balance sheet translations at the exchange rates in effect at each balance sheet date.

Interest

Interest for Q3 2011 increased to \$0.11 million net interest expense versus \$0.09 million expense for Q3 2010. Interest consists of \$0.02 million for interest expense on long-term debt and \$0.10 million for interest and bank charges generally due to the extension of the RBC Master Agreement (Q3 2010-\$0.03 million and \$0.06 million, respectively), offset by interest income of \$0.01 million (Q3 2010-nil).

Equity Loss and Non-Controlling Interest

For Q3 2011, the Company recorded an equity loss of \$0.12 million for its investment in Tribal Nova (Q3 2010-nil). For Q3 2011 the Company recorded nil for non-controlling interest (Q3 2010-nil).

Income Taxes

Income tax for Q3 2011 was \$0.12 million expense (Q3 2010-\$0.13 million recovery) made up of \$0.01 million expense (Q3 2010-\$0.02 million expense) for large corporation taxes, \$0.29 million expense (Q3 2010-\$0.14 million recovery) for current income taxes, and future income tax recovery of \$0.18 million (Q3 2010-\$0.01 million recovery).

Net Income (Loss) and Comprehensive Income (Loss)

Net income and comprehensive income for Q3 2011 was \$0.35 million, compared to \$0.54 million loss for Q3 2010, or an improvement of \$0.89 million in absolute dollars. For Q3 2011, the overall improvement of \$0.89 million was due to changes over Q3 2010 of the following amounts: a gross margin increase of \$2.17 million and a \$0.08 million decrease in net interest and other expenses, which includes amortization, impairment in value of certain investment in film and television, and equity loss, offset by a decrease in operating expenses, net of income from strategic investments of \$1.11 million and a \$0.25 million increase in provision for income taxes.

Changes in Cash

Cash at March 31, 2011 was \$17.94 million, as compared to \$15.34 million, and \$15.92 million as of December 31, 2010, and June 30, 2010 respectively. For the three month period ended March 31, 2011 the cash balance increased \$2.60 million when comparing it to the cash balance as at December 31, 2010.

For the nine month period ended March 31, 2011 cash flows generated from operating activities were \$5.22 million. Cash flows from operating activities resulted from net income of \$1.64 million and adding back non-cash items of amortization of film and television programs, acquired library, PP&E, intangible assets, impairment in value of certain investments in film and television programs, equity loss, unrealized loss on short-term investments, stock-based compensation, and net change in non-cash working capital balances related to operations of \$10.65 million, \$0.45 million, \$0.82 million, \$0.72 million, \$0.45 million, \$0.26 million, \$0.03 million, \$0.34 million, and \$3.84 million respectively. Cash flows were adjusted \$13.32 million for investments in film and television programs, \$0.25 million for unrealized foreign exchange gain, and \$0.41 million for future income tax recovery.

For the nine month period ended March 31, 2011 cash flows generated from financing activities were \$8.75 million. Cash flows used in financing activities resulted primarily from repayments of long-term debt of \$0.41 million and an adjustment to share issuance costs of \$0.10 million. This was offset by cash generated by proceeds of shares related to employee share purchase plan of \$0.01 million, proceeds from bank indebtedness of \$5.72 million, and proceeds from interim production financing of \$3.53 million.

For the nine month period ended March 31, 2011 cash flows from investing activities were a use of cash of \$11.95 million. Cash flows used in investing activities were \$8.01 million for a business acquisition, \$4.00 million for acquisitions of short-term investments, and \$0.97 million for PP&E acquisitions. Cash flows generated in investing activities were \$0.01 million net cash advances from investees and \$1.02 million from proceeds on disposal of short term investments.

Working Capital

Working capital (“**Working Capital**”) represents the Company’s current assets less current liabilities. Working Capital decreased by \$5.85 million as at March 31, 2011 over June 30, 2010, mainly as a result of the DHX Wildbrain acquisition (see Wildbrain Acquisition section of this MD&A). The working capital ratio remained strong at 1.47 for March 31, 2011.

Management was pleased with cash flow provided from Operating Activities of \$3.09 million and \$5.22 million (the three and nine months periods ended March 31, 2010-(\$4.60 million and \$17.79 million) and cash flow from Adjusted Operating

Activities of \$2.42 million and \$8.75 million for the three and nine month periods ended March 31, 2011 respectively (the three and nine month periods ended March 31, 2010-(\$2.79) million and (\$1.09) million cash flow used by Adjusted Operating Activities), as shown in Liquidity and Capital Resources Chart in this MD&A and defined in “Use of Non-GAAP Financial Measures” section of this MD&A. Along with EBITDA, cash flow from Operating Activities and Adjusted Operating Activities are the key metrics for Management in assessing operational performance.

Based on the Company’s current revenue expectations for the remainder of Fiscal 2011 and 2012, which are based on contracted and expected production, distribution, and other revenue, the Company believes cash generated from operations and existing resources will be sufficient to satisfy Working Capital needs for at least the next twelve months. Management believes the current Working Capital surplus totalling \$32.13 million is sufficient to execute its current business plan.

Royal Bank Revolving Master Credit Facility

As of March 31, 2011, the maximum amount of all the borrowing with the Royal Bank of Canada (“**RBC**”) is \$55,000 (“**RBC Master Agreement**”). The RBC Master agreement has been extended to November 30, 2011. As part of the RBC Master Agreement, bank indebtedness was \$5,974 (June 30, 2010 - \$250) (the “**RBC Revolving Operating Credit Facility**”). The maximum amount of the RBC Revolving Operating Credit Facility for general working capital purposes is \$3,510 against which, \$2,115 was drawn at March 31, 2011. In addition, RBC temporarily increased the Company’s RBC Revolving Operating Credit Facility, temporarily for the Wildbrain Acquisition, by a maximum additional US\$ 4,000 (\$3,859) and was fully drawn at March 31, 2011. Under the extended RBC Master Agreement, this temporary increase in the RBC Operating Credit Facility will be replaced by a first drawdown of a term facility with a maximum amount of \$10,000 (“**RBC Acquisition Facility**”) to fund acceptable acquisitions as defined in the RBC Master Agreement. Each advance under the RBC Acquisition Facility will be amortized over 3 years with quarterly payments of principal and monthly payments of interest. The availability of the RBC Revolving Operating Credit Facility and RBC Acquisition Facility is subject to the Company maintaining interest and consolidated indebtedness coverage ratios and certain other covenants.

The Company also has a revolving production credit facility (“**The RBC Revolving Production Credit Facility**”) with the Royal Bank with a maximum authorized amount of \$40.28 million as of March 31, 2011, against which only \$21.46 million has been drawn. The maturity dates for the RBC Individual Approved Tranches vary, but the outside maturity date is October 2012. Please see note 9 of the unaudited interim financial statements for the three and nine months ended March 31, 2011 and 2010 for further details.

Capital Management

The Company’s objectives when managing capital are to provide an adequate return to shareholders, safeguard its assets, maintain a competitive cost structure and continue as a going concern in order to pursue the development, production, distribution, and licensing of its film and television properties. To maximize ongoing development and growth effort, the Company is not anticipating paying out dividends during the year ended June 30, 2011.

To facilitate the management of its capital structure, the Company prepares annual expenditure operating budgets that are updated as necessary depending on various factors, including industry conditions and operating cash flow. The annual and updated budgets are reviewed by the board of directors.

The Company monitors capital using a number of financial ratios, specifically for the RBC Master Credit Facility, including but not limited to (note these are new for Q3 2011):

- Funded Debt Ratio, defined as funded debt (the total of all obligations for borrowed money which bear interest or imputed interest (not including interim production financing), all capital lease obligations, and any contingent liabilities) (“**Funded Debt**”) to consolidated EBITDA; and
- The Fixed Charge Ratio, defined as adjusted consolidated EBITDA (consolidated EBITDA less cash income taxes and unfunded capital expenditures) to fixed charges (consolidated interest expense, scheduled principal payments on Funded Debt, and Company distributions).

The following table illustrates the financial ratios calculated on a rolling twelve-month basis as at:

Outlook

The Company's March 31, 2011 balance sheet remains strong with more than \$27.0 million in cash and short-term investments on hand against only \$6.0 million of bank indebtedness. Management is focusing on its core strengths of developing, producing, distributing, and licensing the best possible quality Children's and Family programs with goals of increasing cash flows from operations and profitability through existing production and distribution streams and emerging music and M&L opportunities, specifically its new initiatives in licensing relating to *Yo Gabba Gabba* and *Rastamouse*. With its remaining net cash on hand and expanded RBC Acquisition Facility, the Company is also seeking acquisition targets to complement its core strengths. Possible opportunities would include additional licensing expertise, additional production capacity and film and television libraries with a proven track record of positive cash flows.

Management feels the economic climate continues to improve and remains optimistic for the remainder of Fiscal 2011 and beyond. Children's programming is off prime time and therefore not as reliant on advertising dollars, and the fact that most of our customer base has a Governmental regulatory mandate to deliver a minimum requirement of children's programming, Management is optimistic that for Fiscal 2012 and 2013, based on its existing pipeline, opportunities for proprietary children's programming will continue to improve.

With nine months of Fiscal 2011 in the books, the Company overall is on track with its previously stated outlook (see the Outlook sections of the annual and Q2 2011 MD&A's on www.sedar.com or www.dhxmedia.com). For clarity, the remaining balance of those targets have been combined to include DHX Wildbrain and adjusted slightly herein based on the relevant current forecasts for the three months remaining in Fiscal 2011.

For the remainder of Fiscal 2011, the Company's target output range is 30-40 half-hours of combined proprietary programs and other proprietary titles with Canadian and other rights. For 2011, the Company is targeting an average license fee per half-hour in the range of \$0.08-\$0.15 million with a goal of being at or above the mid point of the range. When added to actuals for Nine Months 2011, this would represent a range of a 5-10% decrease in proprietary production revenues versus Fiscal 2010 levels. For nine months 2011, the Company's average license fee per half-hour is currently tracking in line with these expectations at \$0.13 million. In addition, the Company expects to add 5-15 half-hours to the library, for third party produced titles where the Company has significant IP rights, including the UK hit *Rastamouse* and *How to be Indie*. As the Company's proprietary pipeline is filling in, Management is encouraged by the progress made on several fronts and expects to announce new commissions and existing series renewals over the next two to three quarters. This pipeline should bode well for increased deliveries in the later half of Fiscal 2012 and 2013.

For the remainder of Fiscal 2011, Management is projecting a target for distribution revenues to be in the range of \$2-\$4 million. The Company remains optimistic it will continue to add third party titles to supplement lower proprietary inventory levels. As evidenced through the Company picking up *Rastamouse*, which has gotten out of the gate with strong pre-sales and licensing potential. For nine months 2011, the Company has already seen significant distribution revenue pickups from such third-party distribution titles as: *Grandpa in my Pocket* Season II, Season II *Spectacle: With Elvis Costello...*, and *How to be Indie* Season I.

For the remainder of 2011, Management's target range is \$3-\$6 million for contracted and expected producer and service fee revenues, when added to \$11.96 million in actuals for Nine Months 2011, would represent a range of 100-140% growth over 2010.

For the remainder of Fiscal 2011, the Company is targeting \$0.75-\$1.5 million in the category of music and royalty revenue, including a range for licensing on *Yo Gabba Gabba* of \$0.5-\$1.0 million. For the remainder of 2011, new media revenue is targeting a range of \$1-\$2.5 million including the property UMIGO. For the remainder of 2011, rental revenues are expected to be generally in line with 2010 levels.

For 2011, Management expects overall gross margin to range from 35-40% range. For the remainder of Fiscal 2011, Management continues to target additional SG&A reductions of 5% on the pre-DHX Wildbrain figures versus 2010, which represents a range of \$2.75-\$3 million. In addition, for the remainder of 2011, SG&A costs for DHX Wildbrain are expected to be in the range of \$1.25-\$1.5 million.

For all of Fiscal 2011, amortization of acquired library and development expense when considered together and amortization of PP&E and intangibles also considered together, are expected to be in the ranges of \$1.3-\$1.5 million and \$2.1-\$2.3 million respectively. For all of Fiscal 2011, stock-based compensation, interest expense, interest income, and equity loss are expected to be in the following ranges respectively: \$0.5-\$0.75 million, \$0.2-\$0.3 million, \$0.2-\$0.5 million, and \$0.3-\$0.4 million.

Media Fund

On January 15, 2010, the holders of the Media Fund (Atlantic) Ltd. ("**Media Fund**") Put Options exercised their rights and exchanged the Put Options for common shares of the Company. As such, the Company has acquired effectively all of the outstanding shares in Media Fund. The consideration for the exchange of the Media Fund Put Options was 425,420 shares of the Company valued at \$391 (see note 3(b) of the audited consolidated financial statements for the year ended June 30, 2010 for further details).

Investment in Tribal Nova and Woozworld

On April 30, 2010 ("Tribal Nova Transaction Date"), the Company's investment in Tribal Nova Inc. ("Tribal Nova") was restructured. In exchange for 670,000 Class A preferred shares of Tribal Nova, the Company received 670,000 preferred shares, representing 4% of Woozworld Inc. ("Woozworld"). The Company also received 4,360,000 Class D preferred shares representing 34% of the shares of Tribal Nova, in exchange for the Company's remaining 1,344,898 Class A preferred shares (see note 3(b) of the unaudited interim financial statements for the three and nine-month periods ended March 31, 2010 and March 31, 2009).

Wildbrain Acquisition

On September 14, 2010, the Company acquired all the outstanding shares in Wildbrain Entertainment Inc. ("**DHX Wildbrain**"), a privately owned company, based in Los Angeles California, for \$8.23 million. DHX Wildbrain operates an animation studio in Los Angeles and is the co-owner of acclaimed children's television series and live touring show *Yo Gabba Gabba!*. Further consideration is payable in USD as an earn out payment calculated as 50% of cash receipts from the *Yo Gabba Gabba!* property over \$10.50-11.50 million (the ultimate threshold amount within the range of \$10.50-11.50 million of cash receipts will be determined based on a minimum of \$10.00 million in cash receipts plus, once achieved, \$0.50 million per year in operating expenses) for a period of 36 months from closing (see note 3(a) of the unaudited interim financial statements for the three and nine months ended March 31, 2011 and 2010 for further details).

Seasonality

Results of operations for any period are dependent on the number and timing of film and television programs delivered, which cannot be predicted with certainty. Consequently, the Company's results from operations may fluctuate materially from period-to-period and the results of any one period are not necessarily indicative of results for future periods. Cash flows may also fluctuate and are not necessarily closely correlated with revenue recognition. During the initial broadcast of the rights the Company is somewhat reliant on the broadcaster's budget and financing cycles and at times the license period gets delayed and commences at a later date than originally projected.

The Company's film and television revenues vary significantly from quarter to quarter driven by contracted deliveries with the primary broadcasters. Although with the Company's recent diversification of its revenue mix, particularly in the strengthening of the distribution revenue stream, some of the quarterly unevenness is improving slightly and becoming more predictable. Distribution revenues are contract and demand driven and can fluctuate significantly from period-to-period.

Critical Accounting Policies and Estimates

The preparation of the financial statements in conformity with Canadian GAAP requires Management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenue and expenses during the reporting period. Management of the Company regularly reviews its estimates and assumptions based on historical experience and various other assumptions that it believes would result in reasonable estimates given the circumstances. Actual results could differ from those estimates under different assumptions. The following is a discussion of accounting policies that require significant Management judgments and estimates. For a discussion of all of the Company's accounting policies, including the items outlined below, refer to note 1 of the audited consolidated financial statements for the years ended June 30, 2010 and 2009 on www.sedar.com or DHX's website at www.dhxmedia.com.

Revenue Recognition

Production and Distribution Revenue

The Company recognizes revenues from the licensing of film and television programs when: a) the Company has persuasive evidence of a contractual arrangement; b) the production has been completed; c) the contractual delivery arrangements have been satisfied; d) the licensing period has commenced; e) the fee is fixed or determinable; and f) collectibility of proceeds is reasonably assured.

Cash payments received or advances currently due pursuant to a broadcast license or distribution arrangement are recorded as deferred revenue until all of the foregoing conditions of revenue recognition have been met.

Producer and Service Fee and New Media Revenue

Revenues from production services for third parties and new media revenue on the Company's proprietary productions are recognized on a percentage-of-completion basis. Associated production costs are charged against earnings as the revenue is recognized. Percentage-of-completion is based upon the proportion of costs incurred in the current period to total expected costs. A provision is made for the entire amount of future estimated losses, if any, on production-in-progress.

Royalty Revenue

Royalty revenue (which beginning Q1 2011 includes licensing revenue from *Yo Gabba Gabba* and the *Yo Gabba Gabba Live!* Tour) is accrued for royalty streams the Company has a history of receiving revenue on and is recognized in periods in accordance with statements received from third party agents and or based on historical experience. Associated tour production and merchandising costs are charged against earnings as the revenue is recognized. A provision is made for the amount of future estimated losses, if any, on production-in-progress.

Variable Interest Entities

The Company follows Accounting Guideline 15 – Consolidation of Variable Interest Entities (“**AcG 15**”). AcG 15 provides criteria for the identification of Variable Interest Entities (“**VIEs**”) and further criteria for determining what entity, if any should consolidate them. AcG 15 defines a VIE as an entity that either does not have sufficient equity at risk to finance its activities without subordinated financial support or where the equity investors lack the characteristic of a controlling financial interest. VIEs are subject to consolidation by a company if that company is deemed the primary beneficiary of the VIE. The primary beneficiary is the party that is either exposed to a majority of the expected losses from the VIEs' activities or is entitled to receive a majority of the VIEs' residual returns or both.

Investment in Film and Television Programs

Investment in film and television programs represents the unamortized costs of film and television programs which have been produced by the Company or for which the Company has acquired distribution rights. Investment in film and television programs also includes acquired film and television libraries. Costs of acquiring and producing film and television programs are capitalized, net of federal and provincial program contributions earned, and amortized using the individual film forecast method, whereby capitalized costs are amortized and ultimate participation costs are accrued in the proportion that current revenue bears to Management's estimate of ultimate revenue expected to be recognized from the exploitation, exhibition, or licensing of the film or television program. For film and television programs produced by the Company, capitalized costs include all direct production and financing costs incurred during production that are expected to benefit future periods. Financing costs are capitalized to the costs of a film or television program until the film or television program is complete. Capitalized production costs do not include administrative and general expenses, the cost of overall deals, or charges for losses on properties sold or abandoned. For episodic television series, until estimates of secondary market revenue can be established, capitalized costs for each episode produced are limited to the amount of revenue contracted for each episode. Costs in excess of this limitation are expensed as incurred on an episode-by-episode basis. Production financing provided by third parties that acquire substantive equity participation is recorded

as a reduction of the cost of the production. Film and television programs in progress represent the accumulated costs of productions, which have not been completed by the Company. For films other than episodic television series and acquired libraries, ultimate revenue includes estimates over a period not to exceed ten years following the date of initial release. For episodic television series, ultimate revenue includes estimates of revenue over a period not to exceed ten years from the date of delivery of the first episode or, if still in production, five years from the date of delivery of the most recent episode, if later. For acquired film and television libraries previously released, ultimate revenue includes estimates of revenue over a period not to exceed twenty years from the date of acquisition.

Revenue estimates are prepared on a title-by-title basis and are reviewed periodically based on current market conditions. For film, revenue estimates include net theatrical receipts, sale of videocassettes and DVDs, licensing of television broadcast rights and licensing of other ancillary film rights to third parties. For television programs, revenue estimates include licensed rights to broadcast television programs in development and rights to renew licenses for episodic television programs in subsequent seasons. Ultimate revenue includes estimates of secondary market revenue for produced episodes only when the Company can demonstrate through its experience or industry norms that the number of episodes already produced, plus those for which a firm commitment exists and the Company expects to deliver, can be licensed successfully in the secondary market.

Estimates of future revenue involve measurement uncertainty and it is therefore possible that reductions in the carrying value of investment in film and television programs may be required as a consequence of changes in Management's future revenue estimates.

The valuation of investment in film and television programs is reviewed on a title-by-title basis when an event or change in circumstances indicates that the fair value of a film or television program is less than its unamortized cost. The fair value of the film or television program is determined using Management's estimates of future revenues and costs under a discounted cash flow approach. A write-down is recorded equivalent to the amount by which the unamortized costs exceed the estimated fair value of the film or television program.

Stock-based Compensation

The Company follows the Canadian Institute of Chartered Accountants Handbook Section 3870 ("CICA 3870"), "Stock-based Compensation and Other Stock-based Payments". Under the amended standards of this Section, the fair value of all stock options granted to employees and consultants are recorded in operations or production costs, as applicable over their vesting periods.

The fair value of options is determined using the Black Scholes option pricing model that takes into account, as of the grant date, the exercise price, the expected life of the option, the current price of the underlying stock and its expected volatility, expected dividends on the stock, and the risk-free interest rate over the expected life of the option. The resulting fair value of the options is expensed on a straight-line basis over their vesting periods. Cash consideration received from employees when options are exercised and the value of options accumulated in contributed surplus is credited to share capital. Stock-based Compensation also includes awards of common shares to certain employees of the Company related to the achievement of certain financial benchmarks.

Investment in Production Companies and Other Equity Investments

The valuation of equity accounted investments is regularly reviewed by Management to ensure that any decline in market value that is considered other than temporary has been reflected in the related carrying value of the investment. In making that assessment, several factors are considered, including the amount by which the market value exceeds carrying value and investees' expected future cash flows and earnings. The Company recorded \$0.12 million and \$0.27 million equity loss for the three and nine months ended March 31, 2011 respectively (nil and nil for the three and nine months ended March 31, 2010) on the statement of income (loss) and comprehensive income (loss) for the respective periods.

In the normal course of business, the Company enters into production arrangements with third party production, distribution companies and broadcasters related to the production of television series or feature films. The wholly-owned production companies in which these production activities are undertaken, are VIEs as they do not have sufficient equity at risk to finance their activities. The Company has variable interests in certain entities but in certain companies, it is not exposed to the majority of the expected losses and, therefore, does not consolidate these companies. The Company accounts for these entities using the equity method.

Goodwill

The Company implements the recommendations of the Canadian Institute of Chartered Accounts ("CICA") Handbook Section 3062, "Goodwill and Other Intangible Assets". Based on this standard, goodwill of the Company is tested for impairment annually on June 30, or more frequently if impairment indicators arise, to determine if an impairment loss should be recognized. Impairment indicators include the existence of significant restructuring plans, the existence of significant adverse changes in the

business climate, and the existence of significant write downs of assets. During the nine months ended March 31, 2011, the Company recorded no amounts for impairment of goodwill (nine months ended March 31, 2010-nil) (See note 11 to the audited financial statements for the years ended June 30, 2010 and 2009 for more details).

Provisions

Balance sheet provisions for amounts receivable and legal issues all require estimates and assumptions by Management that could be significant.

In certain instances, the provision for amounts receivable is based on specifically identified accounts where Management believes that collection is doubtful. These accounts are identified based on customer knowledge and past experience. In other instances, the provision for amounts receivable is based on an allowance for Federal and Provincial government tax credits receivable and is based on historic collection, excluding accounts that have been specifically provided for. Historically, Management's estimate of the required provision has been adequate. Provisions for legal issues are based on Management's best estimate of the probable outcome and resolution of legal matters.

The Company has also booked provisions against investment in film and television programs, current tax, and future taxes payable. These provisions against investment in film and television programs include specific balances where Management believes the likelihood of ultimate revenues is remote and general allowances. Historically, Management's estimate of the required provision has been adequate in the majority of cases (see "Impairment of Certain Investments in Film and Television Programs" section of this MD&A).

Future Tax Assets and Liability

Management's assessment of the Company's ability to realize future income tax assets is performed on a legal entity basis and is based on existing tax laws and estimates of future taxable income. Where, in the opinion of Management, the value of future income tax assets exceeds the estimate of amounts expected to be realized, a valuation allowance or cushion is recorded to reduce the future income tax asset. If the Company's assessment changes in the future, the valuation allowance will increase or decrease accordingly, resulting in corresponding decreases or increases in income, respectively, in that period. The valuation allowance is in no way indicative of the availability of income tax losses or other timing differences to offset future profits earned. Rather, the valuation allowance reduces the future income tax asset to Management's estimate of the future tax asset that will be realized as a reduction of cash income taxes paid in the future.

The above estimates are revised accordingly as new or different circumstances arise. While Management believes the balance sheet provisions are adequate, using different assumptions or estimates could have a significant impact on the Company's results of operations, prospects, or financial condition.

Accounting Policy Changes

Future Accounting Standard Changes

In February 2008, Canada's Accounting Standards Board ("**AcSB**") confirmed that the use of International Financial Reporting Standards ("**IFRS**") will be required for publicly accountable profit-oriented enterprises for fiscal years beginning on or after January 1, 2011. The Company will cease to prepare its financial statements in accordance with Canadian GAAP as set out in Part V of the CICA Handbook – Accounting for the periods beginning on July 1, 2011, when it will start to apply as its primary basis of accounting IFRS as published by the International Accounting Standards Board and set out in Part I of the CICA Handbook – Accounting. Consequently, future accounting changes to Canadian GAAP are not discussed in these financial statements as they will normally never be applied by the Company.

In order to prepare for the initial opening comparative balance sheet under IFRS on July 1, 2011 (the "**Effective IFRS Date**"), the Company is following a three-phase transition plan: initial review and assessment, in-depth analysis, and implementation. The Company has completed the initial review phase.

The second phase is well underway and its completion is planned for the end of Fiscal 2011. In this phase, the Company is performing a detailed analysis of IFRS, including the identification of the differences between IFRS and DHX's current accounting policies, in order to prioritize the key areas that will be more significantly impacted by IFRS and to determine the options permitted under IFRS at the Effective IFRS Date and on an ongoing basis in order to finalize conclusion. This phase also includes detailed planning of IT and HR as they relate to IFRS. To date, the Company has completed detailed analysis of the following:

- a) the differences between IFRS and DHX's current accounting policies;
- b) the key areas expected to be most significantly impacted by IFRS;
- c) the accounting policy options permitted under IFRS;
- d) the impact of the mandatory exceptions included under IFRS 1; and
- e) the optional exemptions available under IFRS 1.

During the remainder of Fiscal 2011, the Company expects to finalize its IFRS accounting policy choices and which, if any, of the optional exemptions provided for under IFRS 1 it intends to utilize. The Company also expects to address any IT or HR issues that may arise as a result of the transition to IFRS. The Company anticipates the cost to complete this phase will be between \$0.05-\$0.10 million for Fiscal 2011.

In the third phase, the Company will implement the accounting changes and any required modifications to internal procedures, controls, and systems so that they are in place and operating effectively for the first fiscal year under IFRS.

IFRS uses a conceptual framework similar to Canadian GAAP, but there are significant differences in recognition, measurement, and disclosures. The International Accounting Standards Board and AcSB will also continue to issue new accounting standards during the conversion period. As a result of the upcoming changes, the final impact of IFRS on the Company's consolidated financial statements can only be determined once all of the IFRS applicable at the Effective IFRS Date are known.

Management is providing the Audit Committee with timely project status updates as well as indications, decision, and conclusions regarding IFRS options.

Financial Instruments and Risk Management

The Company's financial instruments consist of cash, restricted cash, short-term investments, amounts receivable, long-term investment, bank indebtedness, interim production financing, accounts payable and accrued liabilities, long-term debt and obligations under capital leases, and other liability. The Company, through its financial assets and liabilities, has exposure to the following risks from its use of financial instruments: credit risk, interest rate risk, liquidity risk, and currency risk. Management monitors risk levels and reviews risk management activities as they determine to be necessary.

Credit Risk

Amounts receivable from the Canadian federal government and other government agencies in connection with production financing represents 66% of total amounts receivable at March 31, 2011 (March 31, 2010 - 67%). Certain of these amounts are subject to audit by the government agencies. Management believes that these amounts are fully collectible. Management believes that it is normal course for the industry for some amounts receivable to take considerable time to collect; for instance it is normal course for federal and provincial tax credits receivable to take up to 24 months to proceed through audit and collection. The Company adjusts amounts receivable from Canadian federal government and other government agencies including federal and provincial tax credits receivables in connection with production financing, quarterly for any known differences arising from internal or external audit of these amounts. An allowance against federal and provincial tax credits receivable has been recorded based on the Company's history of collection of these amounts.

The balance of trade amounts receivable are primarily with Canadian broadcasters and large international distribution companies. The Company has recorded an allowance for doubtful accounts of approximately 1% against the gross amounts of trade receivables, and management believes that the net amount of trade receivables is fully collectible.

Interest Rate Risk

The Company is exposed to interest rate risk arising from fluctuations in interest rates as its interim production financing and certain long-term debt bear interest at floating rates. A 1% fluctuation would have an approximate \$0.20-\$0.30 million effect on net income (loss).

Liquidity Risk

The Company manages liquidity by forecasting and monitoring operating cash flows and through the use of capital leases and revolving credit facilities (see notes 12, 13, and 14 of the audited consolidated financial statements for June 30, 2010 for further

details). As at March 31, 2011 the Company had cash on hand of \$17.94 million (June 30, 2010 - \$15.92 million) and short-term investments of \$9.08 million in government T-bills, a GIC, and government bonds (June 30, 2010 - \$6.10 million).

Currency Risk

The Company's activities which expose it to currency risk involve the holding of foreign currencies as well as incurring production costs and earning revenues that are denominated in foreign currencies. For every 1% change in the USD, GBP, or Euros exchange rate versus the Canadian dollar there is less than a \$0.10 million impact on net income (loss).

Risk Assessment

The following are the specific and general risks that could affect the Company that each reader should carefully consider. Additional risks and uncertainties not presently known to the Company or that the Company does not currently anticipate will be material, may impair the Company's business operations and its operating results and as a result could materially impact its business, results of operations, prospects, and financial condition. These specific and general risks are as follows: risks related to the nature of the entertainment industry, risks related to television and film industries, risks related to doing business internationally, loss of Canadian status, competition, limited ability to exploit filmed and television content library, protecting and defending against intellectual property claims, fluctuating results of operations, raising additional capital, concentration risk, reliance on key personnel, market share price fluctuations, risks associated with acquisitions and joint ventures, potential for budget overruns and other production risks, management estimates in revenues and earnings, stoppage of incentive programs, financial risks resulting from the Company's capital requirements, government incentive program, change in regulatory environment, litigation, technological change, labour relations, and exchange rates. *For further details see "Risk Factors" contained in the Company's Annual MD&A for the year ended June 30, 2010 and 2009 on www.sedar.com or DHX's website at www.dhxmedia.com.*

Disclosure Controls and Procedures

The Company's Chief Executive Officer ("CEO") and Chief Financial Officer ("CFO") are responsible for establishing and maintaining the entity's disclosure controls and procedures to provide reasonable assurance that all relevant information is gathered and reported to them on a timely basis so that appropriate decisions can be made regarding public disclosures.

The CEO and CFO, after evaluating the effectiveness of the Company's disclosure controls and procedures have concluded that, as at March 31, 2011, the entity's disclosure controls and procedures were effective. It should be noted that while the entity's CEO and CFO believed that the disclosure controls and procedures can provide a reasonable level of assurance, and that they are effective, they do not expect that the disclosure controls and procedures can prevent all errors and fraud. A control system, no matter how well designed or operated can provide only reasonable, not absolute assurance that the objectives of the control systems are met.

Internal Control over Financial Reporting ("ICFR")

The Company's CEO and CFO are responsible for designing ICFR or causing these controls to be designed under their supervision in order to provide reasonable assurance regarding the reliability of financial reporting and the preparation of the financial statements for external purposes in accordance to Canadian GAAP.

Due to its inherent limitations, ICFR may not prevent or detect material misstatements. Also, projections of any evaluation of effectiveness to future periods are subject to the risk that controls may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.

Management, under the supervision of the CEO and CFO conducted an evaluation of control design on ICFR as at March 31, 2011. Based on this evaluation, Management has concluded that the Company's ICFR were adequate and effective to ensure that material information relating to the Company and its consolidated subsidiaries required to be disclosed in the Company's reports filed or submitted under the National Instrument 52-109 would have been known to them.

Changes in ICFR

There were no changes in the Company's ICFR that occurred during the three months ended March 31, 2011 that to Management's knowledge have materially affected or are reasonably likely to materially affect the entity's ICFR.

Use of Non-GAAP Financial Measures

In addition to the results reported in accordance with Canadian generally accepted accounting principles, determined with reference to the Handbook of the CICA ("GAAP"), the Company uses various non-GAAP financial measures, which are not recognized under Canadian GAAP, as supplemental indicators of our operating performance and financial position. These non-GAAP financial measures are provided to enhance the user's understanding of our historical and current financial performance

and our prospects for the future. Management believes that these measures provide useful information in that they exclude amounts that are not indicative of our core operating results and ongoing operations and provide a more consistent basis for comparison between periods. The following discussion explains the Company's use of EBITDA, Gross Margin, and Adjusted Operating Activities as measures of performance.

“EBITDA” and **“Adjusted EBITDA”** means earnings (loss) before interest, taxes, depreciation, amortization, stock-based compensation expense, and for Q4 2010 onward foreign exchange (loss) gain (based on discussions with the Company's auditors it was determined the appropriate disclosure was to include this “below the line” in as a separate line on the Consolidated Statement of Income (Loss) and Comprehensive Income (Loss)) and impairment of certain investments in film and television programs (“Adjusted EBITDA”). Amortization includes amortization of PP&E, acquired libraries, and intangible assets. EBITDA and Adjusted EBITDA represents net income (loss) of the Company before amortization of PP&E, acquired libraries, and intangible assets, interest expense, interest income, non-controlling interest, equity income, development expenses, stock-based compensation expense, and foreign exchange (loss) gain. EBITDA and Adjusted EBITDA are not earnings measures recognized by GAAP and do not have a standardized meaning prescribed by GAAP. Therefore, EBITDA and Adjusted EBITDA may not be comparable to similar measures presented by other issuers. Management believes EBITDA and Adjusted EBITDA to be meaningful indicators of our performance that provides useful information to investors regarding our financial condition and results of operation.

“Gross Margin” means revenue less direct production costs and amortization of film and television programs. Gross Margin is not an earnings measure recognized by GAAP and does not have a standardized meaning prescribed by GAAP. Therefore, Gross Margin may not be comparable to similar measures presented by other issuers.

“Adjusted Operating Activities” is a non-GAAP financial measure of cash inflows and outflows from operating activities adjusted for increases and decreases in interim production financing as, in Management's opinion, these are also an integral part of determining cash flows from operations. Adjusted Operating Activities is one of the key cash flow measurement tools used by Management in assessing cash flow performance.

A reconciliation of historical results to EBITDA and Adjusted EBITDA is presented on the next page.

Reconciliation of Historical Results to EBITDA and Adjusted EBITDA

EBITDA and Adjusted EBITDA are not recognized earnings measures under GAAP and do not have standardized meanings prescribed by GAAP. Therefore EBITDA and Adjusted EBITDA may not be comparable to similar measures presented by other companies or issuers. Investors are cautioned that EBITDA and Adjusted EBITDA should not be construed as alternatives to net income or loss determined in accordance with GAAP as an indicator of the Company's performance or to cash flows from operating, investing, and financing activities as a measure of liquidity and cash flows. The following table reconciles income (loss) before income taxes and discontinued operations, EBITDA and Adjusted EBITDA, and Gross Margin, based on the audited financial statements of the Company for the years ended June 30, 2010 and 2009 and historical unaudited financial statements of the Company for the three months ended March 31, 2011 and 2010, December 31, 2010 and 2009, September 30, 2010 and 2009, and June 30, 2010 and 2009, included elsewhere in this MD&A and the annual MD&A for the years ended June 30, 2010 and 2009 found on www.sedar.com and www.dhxmedia.com.
